

**OWNER APPLICATION FOR WATER SERVICE
TO THE MUNICIPALITY OF SMITHFIELD, UTAH**

The undersigned hereby applies for water service from the municipality of Smithfield, Utah for premises located at: _____, and hereby agrees:

1. To pay charges for such water services as are fixed from time to time by the governing body until such time as I shall direct such service to be discontinued.
2. To be bound by the rules, regulations, resolutions, and ordinances enacted or adopted by the governing body pertaining to the municipality's water service.
3. The municipality shall have the right to discontinue the water system services at its election should the applicant fail to pay charges for said services including all delinquent and reconnection fees. The municipality shall also have the right to discontinue the water system services should the applicant or occupant of the premises fail to conform to the ordinances and regulations established by the governing body pertaining to the use of the water system until all acts of nonconformance are resolved. Prior to discontinuing water system services, the municipality shall provide written notification to the applicant and occupant, should they be different. Notification shall be US Mail addressed to most recent addresses on file at the offices of Smithfield City.
4. To deposit \$ _____ with the municipality on the filing of this application for water service, and it is further agreed and understood that the municipality may, but need not, apply the deposit upon bills due and payable for prior service.
5. The deposit shall not be considered as an advance payment for water service. Charges and unpaid accounts shall be considered delinquent, notwithstanding the existence of the deposit, and the applicant, occupant of the premises, or user of water service shall not have the right to compel the municipality to apply the deposit to any account to avoid delinquency.
6. Upon final settlement of the applicant's account, any unused deposit balance shall be refunded to the applicant.
