The Smithfield City Council met in a specially scheduled meeting at 96 South Main Street, Smithfield, Utah on Thursday, August 22, 2013. The meeting began at 6:00 P.M. and Mayor Simmons was in the chair.

The following council members were in attendance: Dennis Watkins, Kris Monson, Jeff Barnes and Brent Buttars. Barbara Kent was excused.

City Manager James Gass and City Recorder Justin Lewis were also in attendance.

**CANVASS OF THE AUGUST 13, 2013 PRIMARY ELECTION RESULTS**

Justin distributed the Poll Books, State of Disposition of Ballots, Tally Sheets and a spreadsheet listing the election results for early voting, provisional ballots, absentee voting and at the one polling location. All of the documents were reviewed.

Justin reported he had not found any discrepancies with the results as reported.

Justin stated that he was quite happy with the turnout for the primary as normally turnout is very low. The expectation is that the general election will be significantly higher with the school bond issue being one of the voting items. The election will be held again at the civic center/armory and Justin wants to advertise and let people know well in advance of the location and to enter from the east side. The early election went quite well and for the general election a single voting booth will be installed in the city office for voting purposes. Provisional ballots consist of people that have changed names different from the voting book, moved, there is a question of if the person resides within the city limits, or their names is not in the voting book. These votes are completed and put in sealed envelopes. The envelopes are delivered to the county for review and either accepted or rejected. Once accepted they are opened and counted with the rest of the results.

The following candidates were nominated to appear on the November 5, 2013 ballot:

City Council: Kathryn S. Larsen, Barbara Scholes Kent, Kris Monson, and Jeffry R. Gittins.
